**IMPORTANT** - Booths size is 12'x12'. The fee is **\$90** for general merchandise booths and **\$180** for food booths. Additional \$10 fee for electricity. Booths available in the Business District are assigned on a first come, first serve basis. Vendors are responsible for tables, chairs, covers, extension cords etc. Vendors are responsible for a clean up of their booth area during and at the end of the event. **We ask that every vendor please breakdown any cardboard boxes for easier cleanup. Electric hook-ups are limited; please apply early. Vendors NOT located in the Business District are permitted to set up after 9:00 am on Friday, OCT 9th, 2020 and must check in with Jim. Vendors arriving on Saturday must check in at the gazebo on the square 5:30-7:00 a.m. for booth assignment. Your Booth must be set up by 7 am. Vendors set up in the Business District must be unloaded and their vehicle parked off the square in the designated vendor parking area by 7 am. This is a rain or shine event.**

**LATE ARRIVALS WILL NOT BE ABLE TO SET UP. ALL FEES ARE NON-REFUNDABLE.**
